Port users are advised that works involved with the installation of new navigation aids and five mooring within the port waters will commence from the 1st of March. The works are expected to be completed by the mid - April at this stage.

The cargo barge Weerdee Island will be towed by the Multicat Tams Annemarie, with all activities to be carried out during daylight hours only. The cargo barge Weerdee island will be left unmanned at the mooring at night with lights as depicted below.

A 200m exclusion zone is to be observed at the following locations during the installation of the aids to navigation and the day moorings.

The moorings and navigation aids locations will be lit by a yellow SL15 navigational light (Flash On: 0.3, Off: 2.7) during the installation works, when works are being conducted.

The installation works also involves diving activity which will be undertaken from the TAMS Annemarie. The TAMS Annamarie will maintain radio watch on the PoA port channel- 14/16 and will also be available on the Mob- 08 9159 6556. The vessel will display the appropriate lights and shapes.

Mariners and recreational boaters should navigate with caution in the vicinity of the installations work and stay clear of the exclusion zone.
