Port users are advised that, based on the recent hydrographic survey conducted at Ashburton Cargo Wharf (ACW), including the ACW channel and Mineral Resources Limited Terminal (MRLT), the depths have been re-declared as shown in the table below.

Mariners are requested to take note of the changes to these depths. All depths and tides are referred to 'Ashburton Port Datum (2020)'. The area chartlets for the declared depths are shown on the pages below.

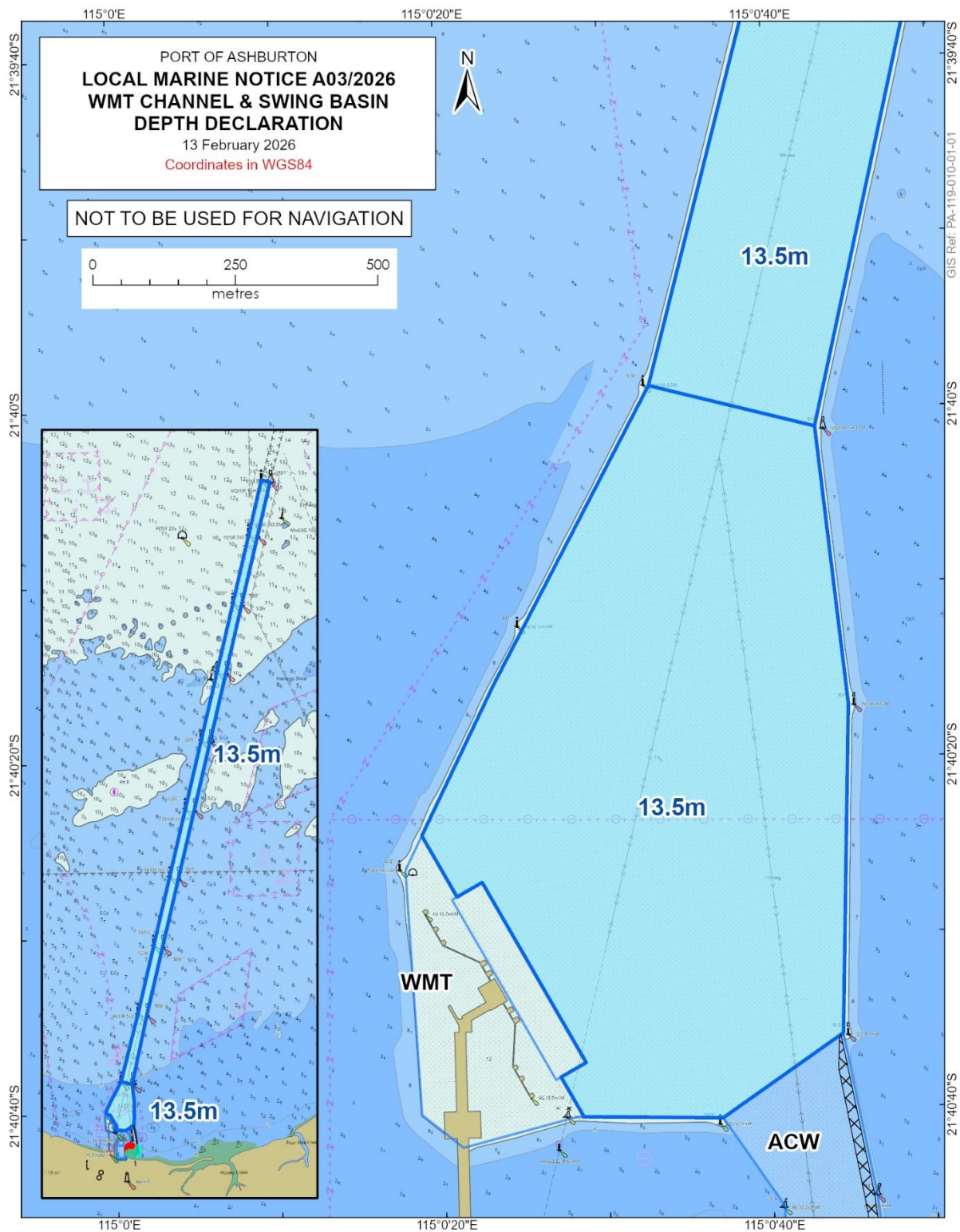

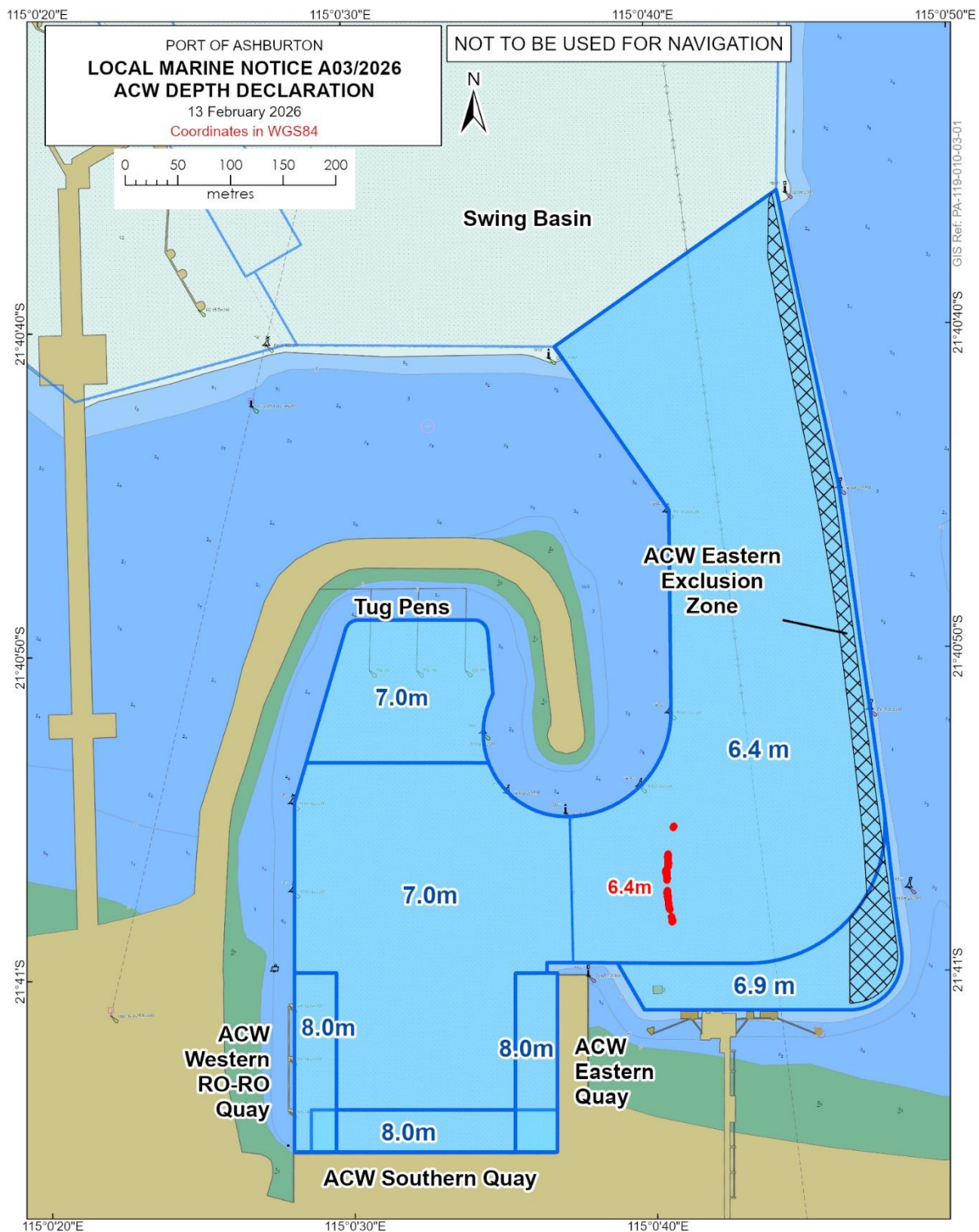

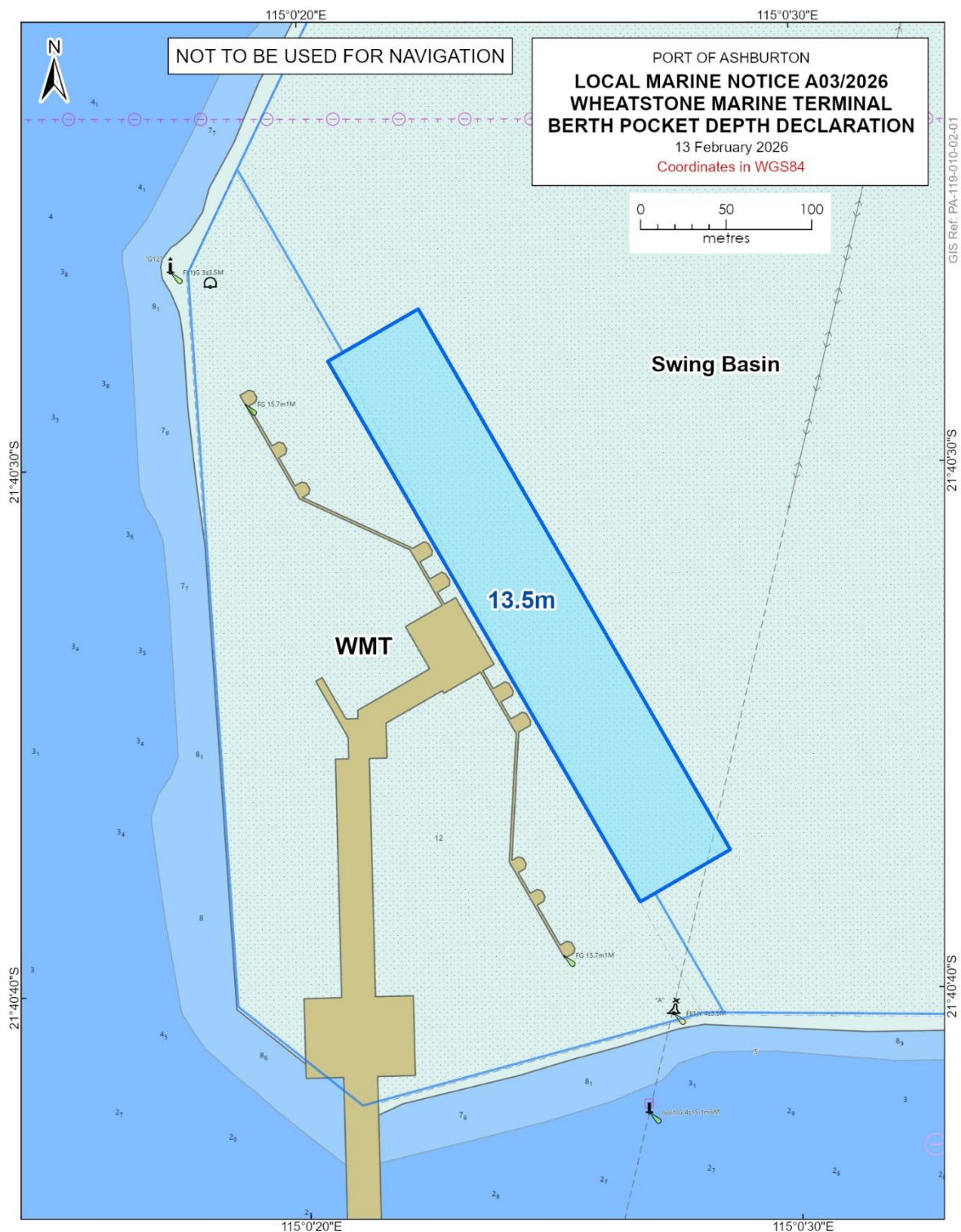


The ACW Eastern Exclusion Zone extends 17m (approx.) inwards from the channel boundary
